Quotes must be in accordance with Lethbridge County specifications and will not be accepted unless submitted on Lethbridge County forms. Companies are welcome to photocopy the Specification pages and Quotation Form if they would like to submit more than one chemical type.

Total figures quoted must reflect the total cost, in Canadian Funds, to Lethbridge County including all items F.O.B. Lethbridge County Picture Butte Yard. G.S.T. must be listed separately but must be included in Total Quoted Price.

Lethbridge County reserves the right to award this RFP as a whole or in part.

Lethbridge County will award contracts based on the proposal evaluation matrix that meets the required specifications of the RFP. However, the County retains the right to reject any or all Quotations and to take into consideration past performance of vendors on similar contracts, both in and out of Lethbridge County and such other factors the County considers relevant including timing of products to be provided. The County shall evaluate all competing quotes in accordance with its own criteria for evaluation applied to the specific item or work being quoted, whether or not such criteria has been expressly related to the vendors. Lethbridge County reserves the right to award the RFP which it deems to be in the best interests of the County. The lowest or any Quotation may not be accepted by Lethbridge County.

If a vendor whose quotation is accepted by Lethbridge County refuses or fails within thirty (30) days after a contract is offered to him for acceptance to execute the terms of the accepted Quotation. The vendor shall then be liable for a penalty to Lethbridge County, for the amount of not less than ten percent (10%) of the accepted quoted price.

# 1. **SPECIAL CONDITIONS**

## 1. **PROPOSAL EVALUATION MATRIX**

1.1 Lethbridge County considers the following requirements of the product and supplier to be of primary importance in the evaluation of proposals for herbicides. Weighting points will be allocated based on Lethbridge County assessment of the submissions where exact numerical assessment (such as price) cannot be made. Only those requirements applicable to the proposal and based on the submission will be considered.

1.2 Proposals where the criteria does not meet a minimum score of four (4) may be rejected. Award shall be based on total points resulting from the sum of the scores for each of the criteria multiplied by the weight assigned.

## 2. **REQUIREMENTS / CRITERIA**

### 2.1 Total price proposed/required to meet specifications 80%

A separate price sheet should be provided. *IMPORTANT\*\* Quotes must be placed in a sealed envelope marked "CONFIDENTIAL – Herbicides, Item No.C60/21"*

### 2.2 Conformance to specifications 10%

Lethbridge County reserves the right to consider variations from the specifications with due regard to their importance. Incomplete specifications risk obtaining a lower score.

### 2.3 Past Experience/Delivery 10%

Lethbridge County will rate each quote with consideration given to past experience including billing, technical support, and delivery. Expected delivery of product to Lethbridge County is by April 29<sup>th</sup>, 2021.
