Letter from the President...

We are currently processing a request for 60 units. **NOTE:** Memberships & unit deposits are still being accepted. Please use the attached form to sign up for extra units, or to sign up a neighboring friend. See application details at the bottom of the page.

We had a great executive meeting on August 30th. The excitement is building as we anticipate great news from CAMRI, with the County of Lethbridge's new grant application for over \$8 million. It is the County's sole application for these monies, and we anticipate hearing some positive news, that the monies will be coming our way, so the flow of water can begin within the year. If we are successful, it works out to about \$13,000 per unit in funding which would be a huge help in keeping the cost per individual unit very affordable.

We hope to be able to put some planning in place this winter, for such things as the Environmental assessment, and the final engineering study. With the new Monarch pipeline going in, it has got the locals really excited to see potable water so close.

A positive outcome on the grant application will be a great morale booster, as many of our members are getting frustrated with the wait.

Your executive is committed to making it happen.
