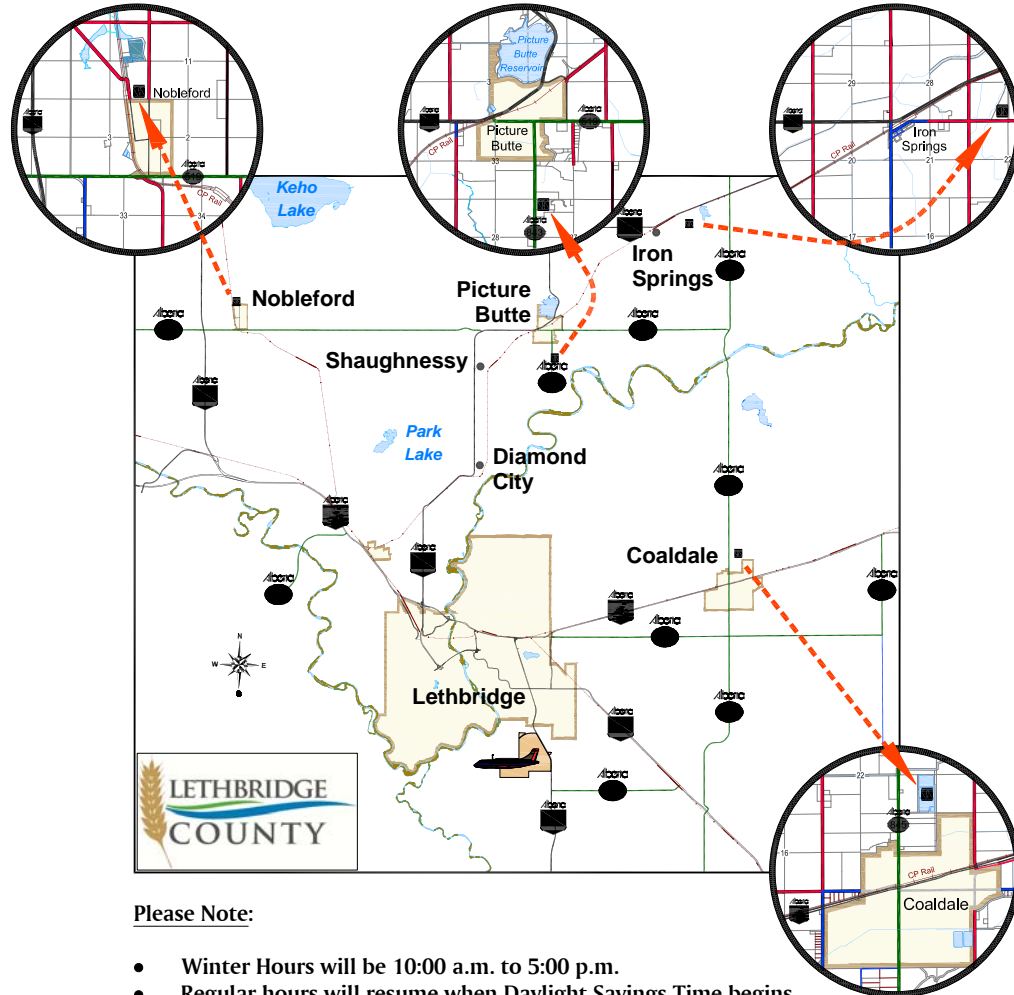

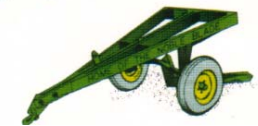
# Transfer Site Information



Lethbridge Regional Waste Management Services Commission

**FEES:** *There will be no fees for members (person living in Lethbridge County, the Town of Picture Butte or the Village of Nobleford) for depositing household garbage (includes lawnmowers, couches, chairs & mattresses) at any of the transfer stations. A fee will be charged to members for commercial type waste. Commercial type waste is anything that is not considered as regular household garbage. Non-member residents will be charged fees. All users will be charged to dispose of:*

- Air Conditioning Units..... \$ 35.00
- Fridges/Freezers..... \$ 35.00
- Water Coolers..... \$ 35.00
- Concrete (per ton)..... \$ 30.00  
(Iron Springs Site ONLY)

*The final decision for fees rests with the Commission.*

**FEES SUBJECT TO CHANGE WITHOUT NOTICE**

- Small amounts up to and including half ton truck..... \$ 40.00
- Amounts up to and including one ton truck..... \$ 75.00
- Amounts up to and including three ton truck (hand sorted).. \$200.00\*  
Subject to the Operators approval or recommendation to haul direct to the Lethbridge Landfill
- Large mixed loads will not be accepted at any site.
- Three ton trucks and all tandem truck trailers must go to the Lethbridge Regional Landfill and pay the posted fees.
- Large loads of rubble will be accepted at Iron Springs only.
- Asphalt roofing material will not be accepted.
- Burning barrels will not be accepted. Ashes must be bagged or boxed.

**HOW TO USE:** There are four transfer stations located within the boundaries of Lethbridge County. They are located at Coaldale, Iron Springs, Nobleford and Picture Butte.

All household waste and garbage will be dumped into the compaction bins found at each of the sites. When these are full, they will be hauled to the Regional Landfill site for emptying. Some wastes such as empty pesticide containers, metal objects (not car bodies), tires, etc. are stored in selected fenced areas. Please follow the instructions of the Site Supervisor in disposing of these materials. Burnable material such as lumber, tree stumps, etc, can be taken to all the sites. HOWEVER, burning will only take place at the Iron Springs location. Please follow the instructions of the Site Supervisor for the proper placement in the designated area. **DO NOT IGNITE** your burnable material. This will be done by the Site Supervisor.

**When transporting your waste material to the Waste Transfer Stations, please have your load properly secured and covered.**

Dry waste or rubble is material with little or no moisture, has no odor, and will not harbor insects and rodents. Concrete construction debris and waste material from building demolition are examples of material that can fit in this category and can be hauled to the Iron Springs site for deposit.

Used oil collection – not to be contaminated by solvents or antifreeze, etc.

**Need for a Regional Waste Management System**

Household waste or garbage is growing at a phenomenal rate each year. It's a major concern for the consumer who creates the waste; municipal and health authorities who have to dispose and control the waste; and the person who wants to protect the environment from pollution.

With encouragement and capital funding from ALBERTA ENVIRONMENT, the Lethbridge Regional Waste Management Services Commission administers the planning, construction and operations of the Regional Waste Management System. This authority is composed of representatives from LETHBRIDGE COUNTY, the TOWN OF PICTURE BUTTE and the VILLAGE OF NOBLEFORD. In designing a waste management system, the commission has considered the particular requirements and needs of the residents in the areas represented and each of these has been considered in the design of the system.

- Elimination of garbage dumps, over the edge coulee type of dumping and the problems that are created by these systems.
- The controlled collection of household waste at area transfer stations which is then moved to a central regional landfill.
- Controlled storage of pesticide containers, metal (not car bodies), tires, rubble and dry fill.
- Control of burning at sites.
- Improved handling and control of waste material.
- Promote recycling and composting.
- E-Waste and household toxic waste all year round.
- Paint waste all year round.

Disposal compounds are provided at all sites. Please triple rinse and puncture your containers at home. Separation of plastics and metal containers, in cooperation with the site attendant on disposal is required. Remember the waste management system is your system. With your cooperation we can keep it working effectively.

**RECYCLABLES:** Removal of recyclable materials from the waste stream is the best way to reduce our volume of waste. Please use the recycling containers.

**LRWMS NEIGHBOURS PRIVILEGE WASTE DISPOSALCARD:** This card has been made available for those wanting to dispose of their regular mixed waste (household waste or garbage) directly in the City of Lethbridge Landfill.
