- REASONS:**
1. The Subdivision Approval Authority has determined the proposed subdivision conforms to the Direct Control bylaw and land use district regulations applicable to the parcel.
 2. The Subdivision Authority is satisfied that the proposed subdivision is suitable for the purpose for which the subdivision is intended and will assist with storm water drainage management, pursuant to Section 7 of the Subdivision and Development Regulation.
 3. The proposed subdivision is for a Public Utility Lot (PUL) which will be owned and maintained by the County of Lethbridge for storm water management purposes. CARRIED

Reeve Hickey welcomed the delegation to the meeting. The delegation consisted of:

Reeve Hickey declared the public hearing is being held pursuant to the Municipal Government Act as amended for By-Law #1397 Land Use Bylaw Amendment Rezoning to Direct Control (DC) - NE ¼ 33-7-20-W4, Bradeck Enterprises.

Reeve Hickey invited Ms. Hilary Janzen, Development Officer/Senior Planner to give an overview of the application.

Ms. Janzen stated the following:

- First reading of Bylaw 1397 was approved on June 6, 2013.
- The purpose of the amendment to the Land Use Bylaw is to rezone a 10 acre parcel from Rural Agriculture (RA) to Direct Control (DC).
- The applicant requires a larger site for their current business (trucking and warehousing facility) that is being operated out of the property directly west of the proposed rezoning area.
- In order to continue the expansion of their business the applicant approached the landowner of the NE ¼ 33-7-20-W4 to acquire a 10 acre parcel to expand and relocate their business.
- The applicant currently has a Development Permit (#99-65) for a trucking business on their three acre parcel, but they have exceeded the parameters of that Development Permit as their business has evolved and grown over the last 14 years.
- The intended use of the 10 acre parcel is a trucking and warehousing facility. In consultation with the County Administration and the Oldman River Regional Services Commission, it was concluded that the current Rural Agricultural District was not the appropriate District for the site and a rezoning would be required.
- The intended use for the 10 acre parcel is not permitted or discretionary under the Rural Agriculture District and given the specific uses requested for the property a Direct Control District was identified as the most appropriate option.
- The application of a conventional district, such as Rural Grouped Industrial or Rural Commercial, on this property would allow for a wide variety of potential uses on the site that may not be appropriate given the proximity to existing residential properties.
- The Direct Control District will provide County Council and Administration with a high level of certainty regarding the permitted and discretionary uses of the property.
- The Direct Control District will also limit the uses on the property mitigating any potential negative impacts on the neighbouring residential uses and allowing the applicant the opportunity to expand their current business.
- If the rezoning application is approved the applicant will have to subdivide the 10 acre parcel and submit a development permit application that would be ultimately approved by County Council.
- The proposed rezoning application was circulated to the other County Departments and to Alberta Transportation.
- Alberta Transportation indicated that the applicant would require a permit from Alberta Transportation given its proximity to Highway 4 which is classified as a Freeway/Expressway.
- There were no comments from the other County Departments.
- Adjacent landowners were sent a notification of the bylaw on June 26, 2013. A notice of the Bylaw and Public Hearing was advertised in the Sunny South News on July 16 and 23, 2013.

Reeve Hickey asked if Council had any questions of Ms. Janzen.

Council asked if the trucking company was located in the easterly portion of the parcel. Ms. Janzen indicated yes.

Council asked why the area was not appropriate for district? Ms. Janzen noted that the applicants wanted to expand their business and purchasing a 10 acre parcel adjacent to their current parcel was the best solution for them. The landowners of the property, proposed to be rezoned, are in favor of selling the applicants the 10 acre parcel upon successful rezoning and subdivision.

Council asked what type of trucking operation the applicant has. Ms. Janzen noted dry freight, non-hazardous.

Council noted that there is a slight jog in the property. Would it be possible to square the property off? Ms. Janzen noted that it could be done at the subdivision stage.

Council had no further questions at this time of Ms. Janzen.

Reeve Hickey asked if anyone present wished to speak in opposition of By-Law 1397 three times. No one came forward.

Reeve Hickey asked if anyone present wished to speak in favor of Bylaw 1397. Randy & Elaine Heidt, applicants came forward.

Council asked the applicants if their trucks travel on the gravel road pasted the other acreages. Mrs. Heidt replied yes they do and that calcium chloride has been applied on the road to keep the dust down. Council asked if there are any other truck yards in the area. Mrs. Heidt replied no. Mrs. Heidt further noted that they have resided and had their trucking business in this area for 14 years and wish to stay in the area. By purchasing the adjacent parcel to expand their trucking business, trucks and trailers can be parked on the property and left there. Currently trucks are being parked in the City.

Council questioned if there was a home on the property. Mrs. Heidt replied there is a home on the current three acres.

Reeve Hickey asked if there were any other questions. There were no further questions.

Mrs. Heidt noted that the adjacent landowner has asked that the applicant purchase the little piece to square off the property. There will then be two titles – one for the home and one for the business.

Council noted that the current three acre parcel would remain as Rural Agriculture and the other 10 acres parcel would be designated as direct control. Ms. Janzen replied that is correct.

Council questioned whether the parcel is subdivided? Steve Harty, ORRSC noted that the current three acre parcel is subdivided. Ms. Janzen indicated that if the applicants are successful, they are then able to purchase the adjacent 10 acre parcel. The parcel would then have to be subdivided and apply for a development permit.

Council questioned that you would have to complete two subdivision applications? Mr. Harty noted that the current three acre parcel would have a small piece added to it and the other parcel would be the expansion of the business.

Mr. Harty further noted that the Direct Control designation is specific to the business. If there is a change in the business, the applicants would have to come back to Council.

Council asked if Alberta Transportation commented on the application. Mr. Harty noted that Alberta Transportation indicated that the applicants would require a permit from them because of the highway. Council noted that they felt that a Traffic Impact Assessment would be warranted due to the increase in truck traffic. Mrs. Heidt indicated that there have been many trucks on the gravel road for many years. Mrs. Heidt's neighbors also run a trucking business and have worked for Heidt's in the past.

Council also noted that from the comments received from Alberta Transportation indicates that they have no problem with the business expansion. If there was a problem with the expansion, the County would have been notified by Alberta Transportation.

Mr. Heidt indicated that there is a merge lane on Highway 4. Mr. Heidt further noted that the trucks are out of town anywhere from one week to ten days at a time. The trucks and trailers are then located on the property on the weekend.

Reeve Hickey asked if anyone else wished to speak in favor of Bylaw 1397. No one came forward.

Reeve Hickey asked if there were any further questions. There were no further questions.
