Some portions of your tax contributions are pre-designated by the province to meet essential requirements, like education, senior housing & care, and law enforcement. The remaining funds are managed at the discretion of the County.

#### Where does the rest of the money come from?

To help minimize the amount of property tax needed to fund operations, the County uses other sources of revenue, like:

- Grants
- Sales of goods/services (rental fees, permits, etc.)
- Service agreements
- Return on investments
- Transfers from reserves
- Fines/penalties

#### What about the future?

In an effort to be future-focused, a \$2.4 million increase was put in the 2024 budget for reserves, above the 2023 budget allocations. Reserves exist to aid in mitigating cost increases due to factors like inflation, as well as provide funds for new projects, infrastructure & asset replacement and debt reduction, in preparation for the future, ensuring the sustainability and viability of the County.
