COUNTY OF LETHBRIDGE NO. 26 IN THE PROVINCE OF ALBERTA BYLAW NO.1139

BYLAW NO. 1139 OF THE COUNTY OF LETHBRIDGE NO.26 FOR THE PURPOSE OF ESTABLISHING THE PREREQUISITES FOR OPERATING A BUSINESS WITHIN THE LANDS OF THE LETHBRIDGE AIRPORT.

WHEREAS the County of Lethbridge No.26 has purchased the Lethbridge Airport from Her Majesty the Queen.

AND WHEREAS the Municipal Government Act provides that a Council has natural person powers and may pass a Bylaw to regulate or prohibit activities as well as deal with any activity.

AND WHEREAS the County of Lethbridge No. 26 deems it just to establish regulatory controls for the operation of commercial activities conducted at the Lethbridge Airport.

NOW THEREFORE, the County of Lethbridge No. 26 in the Province of Alberta, duly assembled, enacts as follows:

Section 1 - Name of Bylaw

1.1 This Bylaw may be cited as the "Lethbridge Airport Business Operating Prerequisites"

Section 2 - Interpretations

- 2.1 "Airport" means the Lethbridge Airport.
- 2.2 "County Manager" means the County Manager for the County of Lethbridge No. 26.
- 2.3 "Council" means the Council of the County of Lethbridge No.26
- 2.4 "Commercial passenger vehicle" means a motor vehicle used in the transportation of persons for compensation.
- 2.5 "authorization in writing" means by letter of consent, contract, permit or lease\licence.

Section 3 - Authority to impose Charges, Rates and Fees

3.1 Council authorizes the imposition of charges set forth in sections 4.1(e) as well as negotiated rates/fees for contracts, permits or leases\licences issued for activities listed in 4.1 (a) through (d).

Section 4 - Prohibited Operations

- 4.1 Except as authorized in writing by the County Manager, no person shall
 - (a) conduct any business or undertaking, commercial or otherwise, at the Airport;
 - (b) advertise or solicit at the Airport, on his/her behalf or on behalf of any person; or
 - (c) fix, install or place anything at the Airport for the purpose of any business or undertaking.

- (d) operate a commercial vehicle for the pickup and transportation of persons on the Airport, without arrangements for the transportation being made by or on behalf of the passenger prior to the commercial vehicle's arrival at the Airport.
- (e) operate any motor vehicle or mobile device used in the direct fuelling or defuelling of aircraft without a registration certificate. Certificate fees are calculated at multiplying the gross weight of the equipment in kilograms, by \$0.033 or \$15.00, whichever is the greater amount.

Section 5 - Penalties

5.1 Subject to this Bylaw, any person violating any of the provisions of this By-law or any other person responsible for such violation shall be liable on conviction before a Provincial Judge or any Justice of the Peace having jurisdiction therein, to a penalty not exceeding \$450.00 excusive of costs.

Section 6 - General

- 6.1 The County Manager may require businesses requesting the right to conduct operations on the airport to deposit a security in the form of a bond or letter of credit, to ensure full payment of their account, should that account fall into arrears.
- 6.2 In the event a permitted business fails to maintain public liability insurance, the letter of consent, contract, permit or licence may be suspended until insurance requirements are fulfilled.
