3) Community Grant Program Policy Options

Council approved that Community Grant Policy #176 be rescinded and further, that a \$10,000.00 grant to each of the seven community hall associations located in the County and the Prairie Tractor and Engine Museum be provided in 2020, subject to the satisfaction of County administration, that each group is able to lawfully receive and appropriately manage such funds on behalf of their respective organizations.
