

Council Brief of the October 1, 2018 Regular Meeting

APPOINTMENTS:

1) 10:30 am- Shawn Lapointe Re: Presentation of Alberta Emergency Services Medal Council congratulated Officer Lapointe and thanked him for his 12 years of service to the citizens of Alberta and Lethbridge County.

2) 1:30 pm- Martin Ebel, EDO, Re: Introduction of University of Lethbridge Applied Studies Student Jill Muirhead

Council welcomed Ms. Muirhead to Lethbridge County.

3) Notice of Motion- Councillor Horvath made a Notice of Motion that at the regular Council meeting on October 18, 2018 he will make a motion that Twp. Road 9-4 be included in the 2019 Budget and that the road be made into a haul route with either oil or calcium applied from 1 mile west of 43 Street to Highway 845.

- a. SD Application 2018-0-132- Jan Henrik Verduyn & Jacoba Verduyn- NW ¼ 7-12-19-W4 The application was approved subject to the conditions outlined on the draft resolution.
- b. SD Application 2018-0-133- Harley Berg, Esther Berg, Arnold Janz & Jeryn Janz- NE ¼ 20-9-20-W4 The application was refused for the reasons outlined on the draft resolution, as the proposal does not comply with the subdivision criteria or policies per the Land Use Bylaw No. 1404.
- 5) 2:00 pm- PUBLIC HEARING- Bylaw 18-020 Land Use Bylaw Amendment- Cannabis Retail Sales and Legalization

Council approved the amendments to the bylaw on second and third reading, which include:

- 1) Remove "Medical Marihuana Production Facility" terminology from *Part 2 Land Use District Regulations, Rural General Industrial (RGI) land use district (2) Discretionary Uses,* and *Part 4, Use Specific Land Use Provisions'*, and replace with "Cannabis Production Facility".
- 2) A Retail Cannabis Store shall not be approved for a development permit if the premises is located within a 300 metre (as amended from 100 metre) separation distance of: a provincial health care facility, school (public or private), an approved child or daycare facility, a school reserve or municipal and school reserve under the Municipal Government Act, a municipal park or playground facility, a church, community centre, library or recreation facility where persons under 18 years of age may attend or congregate.
- 3) *Part 4, Use Specific Land Use Provisions* amended to: "The requirements of this section apply to any and all cannabis production facilities, as defined by the Land Use Bylaw and are in addition to any federal regulations required by the Government of Canada."

1) Bylaw 18-022- Schedule of Fees- 3rd Reading

Council approved the bylaw and further that Municipal Services develop a policy for working on private property to be brought to a future Council meeting.
